### **Pastor's Letter**

Beloved Eliot,

After two years in a pandemic that has taken the lives of 850,000 Americans and 5 million others around the world, the thing I most want to say to you as your pastor is simple: I love you each and I miss you. I miss the joyful chaos of your children in worship, children who are now two years older, taller, and smarter than when we last all gathered in the sanctuary. I miss the unbounded, Spirit-filled singing of our choirs and impromptu drummers. I miss long peace-passing with hugs and smiles that are not hidden under masks. I miss quick check-ins during the postlude and praying with my hand on your shoulder in the pews after worship. I miss the casual way we could always count on someone to help if we needed another greeter, usher, or Sunday School teacher. I might even miss stealing a chicken nugget from the trays headed to the Sunday School classrooms. And I miss seeing you share all of these things with one another.

COVID has taken many things from us in these two years. Some we can name easily and grieve openly. But others — like the sense of community that comes when a diverse group of people gathers week after week to worship, fellowship, and learn — are difficult to articulate. These losses leave a nagging emptiness that we cannot quite put a finger on for something we are not sure how to reclaim.

Please don't get me wrong: we have done so much that we can be proud of this year. We have invested in hybrid worship and we do it well; congregations in our presbytery and beyond frequently contact us for tips and best practices. We have built a professional and compassionate ministry to our neighbors who have no place to call home; we are a respected partner among service providers in Lowell. Our Cambodian community has deepened their faith through Bible study led by Rev. Thysan Sam and June Taing, our newly commissioned Lay Pastor. Even the finances of the church are healthy. But the glory of these accomplishments wanes if our communal bonds are not healthy and strong.

While I love and miss that spark that makes us "Eliot," it is not only our community spirit that unites us. The real source of our unity and our strength is Jesus Christ who builds us

together by his Holy Spirit into a dwelling place for God (Ephesians 2:22). If the COVID pandemic has battered our community spirit, then perhaps we might think of 2022 as a "rebuilding year." Like survivors of a natural disaster, we will need to enter the rubble, mourn our losses, release what cannot be repaired, and hold fast to all that is still good and strong and useful.

Beginning in March, I will take three months of sabbatical leave for rest and renewal. During this time, I will be thinking about my own spiritual wellness and the gifts you need from me as your pastor and leader. I hope you will use this time to reflect on why this community is important to you and how God is calling you to be formed here. You will be guided by wise and thoughtful preachers who offer a voice different from my own. I hope you will remain faithful in worship or return if you have been away awhile. My sabbatical will also offer opportunities for you to reconnect with each other through intentional gatherings. I hope that everyone will attend at least one of these events and reconnect with your siblings in the faith. The elders of the congregation are also preparing for renewal in their leadership, taking stock of what to release and what good foundations to build upon. When I return in June, I hope we can celebrate together with joy and look with clear eyes and open hearts at the ministry God is preparing for us.

I do not know what 2022 holds in terms of the Coronavirus. And I do not know what Eliot Church will look or feel like in the year ahead. Things may never look exactly like they did before, and it is good to grieve and lament what is lost. But as we turn the page on a new year, we cannot hope for what used to be. We hope in Jesus Christ who promises to dwell among us when we build our community upon his Word and Spirit. As we enter this new year, I pray that our season of grieving and reflection can give way to a new spiritual era in the life of Eliot — one marked by connection, service, and joy.

# **Outreach Committee**

In 2021 the Outreach Committee served as the Steering Committee for our Day Center.

In the spring, Sierra led us in a conversation about strengths, weaknesses, opportunities, and threats for the Day Center. The process brought out many joys and many challenges and will help us decide where to focus our attention in the future.

Hiring staff for the Day Center was a significant focus this year. A sub-group worked with Heather on job descriptions for Director of Operations, Assistant Manager, Chaplain, and Director of Social Services. We posted our job openings on Eliot's website and Indeed, and shared them with MCC, UMass Lowell, the Greater Lowell Health Alliance and UTEC as well as our own networks. We interviewed candidates, and Eliot Church filled the positions of Director of Operations, Director of Social Services, and Assistant Manager. The positions of Chaplain and Caretaker were still open as the year ended. Bridgewell Counseling Services in Lowell sent us an employee at their expense who works 12 hours per week in a customer service role; this has been a big help while positions remain unfilled.

We hoped to form a hospitality team for Sunday mornings. This team would help the congregation welcome newcomers, including our homeless neighbors. We invited several people to join the hospitality team, but so far no one has agreed to serve in this role.

Outreach Committee decided to present information about the Day Center to the congregation on Sunday mornings to keep everyone informed. Lori and Scott had a turn, and Bea made a welcome video introducing Karina when she was hired.

Pastor Heather does the work of applying for grants to fund the Day Center; the committee supports her with proofreading and keeping an eye out for new grants we can seek. Applications made in 2021 to fund the Day Center in 2022:

Synod of the NE — pending, \$18,000 Federal grants through the City of Lowell — awarded, \$39,800; pending, \$47,000 Greater Lowell Health Alliance — awarded, \$20,000 Parker Foundation — pending, \$39,000 Cummings Foundation — pending, \$25,000

## **Board of Deacons**

2021 continued to be a challenging year in terms of in-person gatherings. As deacons we sought to mediate the need for contact within the body of Christ as well as continuing our regular duties of care within the larger community. We met 10 times, missing September and December, and sought to be faithful to our commitments.

While weather permitted, we met in person, sharing a meal with each other outside, and as the weather changed, given our space and our numbers, we continued this practice while maintaining social distancing. We also instituted a devotional time led by different deacons at the beginning of the meetings. Caring for each other was a priority. Additionally, we incorporated into our meetings time to contact some of our shut-ins or absent members by making phone calls or writing cards. We also hosted as deacons a meal for the graduates in our midst and led the youth in what has become an annual tradition of caroling during the Christmas season.

#### Deacons, continued

One of our new duties was to organize the preparation and serving of food for St. Paul's Soup Kitchen, given the departure of Bill Hall and others who for years had been helping fund and facilitate our service to St. Paul's. Not finding a facilitator willing to take on full responsibility for the task, Bernie Campbell and Sothara Ly agreed to shoulder the bulk of the responsibilities and to help find within our church community those groups which would agree to cook and serve the meals at particular intervals. We now have in place two to three groups that have agreed to take on this task: the Men's Group, the Cambodian group, and CWF, which came through in helping to prepare a meal. We are still working to recruit another group to aid in this ministry opportunity.

Additionally, food donations to the Food Pantry, communion set-up, helping with the Thanksgiving meal (thanks, Bernie, for delivering meals to those who could/would not come out), and our commitment to Angel Tree all continue.

We want to thank all the faithful in the congregation that reach out to others, embracing them as they can during this long and dark season of Covid. Every phone call, every card, every virtual touch, every eye that sees and acknowledges the other, helps to keep our family threads knit together, creating a safety network where we are held.
